
Please refer to your letter no. PRI/482/PGMEB/2023 dated 31.08.2023 whereby Compliance Report was furnished in respect of the deficiencies pointed out by the PGMEB vide letter no. 35/102(36)/2022-PGMEB/045640 dated 01.08.2023. In this regard, it is informed that the aforesaid Compliance Report was considered by the Post Graduate Medical Education Board (PGMEB) and based on the reply furnished by the college/ institute, approval of the PGMEB is hereby accorded in terms of Section 25(i) and 35(4) of NMC Act, 2019, for grant of **Recognition of MS(Ophthalmology) qualification for 02 seats in respect of students being trained at NRI Institute of Medical Sciences, Visakhapatnam under Dr. Y.S.R. University of Health Sciences, Vijayawada, Andhra Pradesh**, under the following terms and conditions, as contained in the Post Graduate Medical Education Regulations, 2000:

- (i) *The recognition so being granted herein, shall be valid for a maximum period of 05 (five) years from the year 2022, upon which it shall have to be renewed.*
- (ii) *The procedure for 'Renewal of Recognition' shall be same as applicable for the award of recognition.*
- (iii) *Failure to seek timely renewal of recognition as required in sub-clause (i) supra shall invariably result in stoppage of admissions to the concerned Post Graduate Course of the said institute.*

2. The approval for Recognition of MS(Ophthalmology) qualification for 02 seats is granted subject to applicability of amendments in NMC Regulations from time to time.

3. Further, The report of the Aadhaar Enabled Biometric Attendance System (AEBAS) shows that the Senior Residents in the Department are not marking attendance on the AEBAS. Therefore, the medical college is directed to ensure that all the faculty members mark attendance on AEBAS. A report in this regard may be sent to the Postgraduate Medical Education Board of National Medical Commission within one month from the date of issuance of this letter.
