In exercise of the powers conferred by Sections 25(i) and 35(4) of NMC Act, 2019, the approval of PGMEB, NMC is hereby conveyed for grant of **Recognition of MS(Orthopaedics) qualification for 04 seats in respect of students being trained at NRI Institute of Medical Sciences, Visakhapatnam under Dr. Y.S.R.
